# World Egg Day! Friday 10<sup>th</sup> October 2025

These rules apply to the 'World Egg Day!' competition (hereinafter referred to as "the competition"). This competition is being run by: The South African Poultry Association (SAPA). By entering the competition, you confirm that you have read and agree to be legally bound to these rules.

#### 1. WHEN DOES THE COMPETITION START AND END?

The competition starts at 09h00 Friday 10<sup>th</sup> and will continue until 09h00 Monday 13<sup>th</sup> October 2025. This is the competition period. SAPA reserves the right to extend the duration of the competition, subject to these terms and conditions.

# 2. WHO MAY ENTER THE COMPETITION? (WHO QUALIFIES FOR ENTRY INTO THE RANDOM DRAW?)

All natural persons residing in South Africa, including South African Citizens and Foreign Nationals over the age of 18 years may enter the competition. To claim the prize money, each winner must submit a copy of a valid identity document and a bank account confirmation letter bearing an electronic stamp. The name on both the

identity document and the bank account must exactly match the name associated with the winner's Instagram or Facebook account. Failure to provide the required documentation will result in disqualification and forfeiture of the prize.
