

World Egg Day

Friday October 4th, 2024

These rules apply to the 'World Egg Day' competition (hereinafter referred to as "the competition"). This competition is being run by: The South African Poultry Association (SAPA). By entering the competition, you confirm that you have read and agree to be legally bound to these rules.

1. WHEN DOES THE COMPETITION START AND END?

The competition starts at 09h00 Friday 4th October and will continue until 16h00 Saturday 12th October 2024. This is the competition period. SAPA reserves the right to extend the duration of the competition, subject to these terms and conditions.

2. WHO MAY ENTER THE COMPETITION? (WHO QUALIFIES FOR ENTRY INTO THE RANDOM DRAW?)

All natural persons residing in South Africa, including South African Citizens and Foreign Nationals over the age of 18 years may enter the competition. To qualify to receive the prize you must have a valid and an operational South African bank account. You must also have complied with all competition mechanics which are elaborated on in the "How to enter" section (point 4).

3. WHO MAY NOT ENTER THE COMPETITION?

The following persons may not take part in this competition even if they qualify to enter. They will forfeit (give up) any prizes awarded to them:

4. HOW TO ENTER?

You need to make sure the person in the photo is holding up a piece of paper which clearly displays the name of the Facebook account you are entering on, the date you took the photo and the words World Egg Day 2024. 5. PRIZES

Four (4) entrants will be randomly selected (by SAPA) to win R1 000 cash each.

6. HOW WE WILL DELIVER YOUR PRIZE TO YOU

The cash prize will be paid into the winner's personal South African bank account via EFT. The organisers will contact the winner via private message on Facebook/Instagram to obtain identity and banking details. Prizes will be deposited into the winner's account within 30 (thirty) working days of receiving banking details.

7. HOW WILL WINNER BE NOTIFIED?

The winner will be notified via a private inbox message on Facebook/Instagram and their name will be announced on the [EGGcellentFood](#) Facebook and [EGGcellentFoodSA](#) Instagram pages on Monday 14th October 2024.

8. WHAT HAPPENS IF SAPA CANNOT CONTACT THE WINNER OR IF THE WINNER IS NOT ABLE TO TAKE UP THE PRIZE?

If SAPA is unable to get hold of any prize winner(s) within 7 (seven) days after the prize announcement date, SAPA will select another winner/s, and the prize will be awarded to the lucky winner/s who has/have met all the conditions of the competition rules.

9. GENERAL

- SAPA has the right to end this competition at any time. If this happens, SAPA will publish a notice on Facebook, and you agree to waive (give up) any rights that you may have about this competition and acknowledge that you will have no rights against SAPA.
- SAPA reserves the right to change the rules of the competition. SAPA will publish changes on SAPA's website: [SA Poultry](#) and SAPA's Facebook [EGGcellentFood](#) and Instagram [EGGcellentFoodSA](#) pages.
